

# **Changes in Price**

Following a strong Q4 2024 performance, all segments of publicly traded asset underperformed the S&P 500 in Q1 2025. Alternative asset managers and larger companies (AUM over \$250 billion) experienced a double-digit decline of 18.7% and 10.4%, respectively, during the quarter while smaller asset managers (AUM under \$250 billion) experienced a smaller decline of 8.1%. These measures contrast against a 4.1% loss for the S&P 500 during the quarter.


Year-over-year performance was positive for all groups of RIAs as well as the S&P 500, and was especially so for alternative asset managers which saw a total return of 14.8% amid rate cuts, disinflation, and recovering M&A activity. Both the smaller and larger groups of traditional investment managers underperformed the S&P 500 for the year.





# **Changes in Valuation**


After trending downwards for most of 2023, multiples began to increase with the overall market during the fourth quarter of 2023 and continued to increase through 2024. The median Enterprise Value to LTM EBITDA multiples for public RIAs decreased across the board in Q1, including alternative asset managers, which still trade at a considerable premium to their peers given the often-significant balance sheet investments held by alternative managers.





## **Changes in Fundamentals**


Traditional RIAs experienced a year-over-year increase in AUM which outpaced the revenue growth during the same period--a sign of fee compression. Alts revenue, on the other hand, increased at a higher rate than AUM. As shown on Slide 2, the S&P 500 returned 8.5% year-over-year, providing a tailwind to AUM growth for most firms. AUM growth for all groups of RIAs examined were in line with or slightly exceeded growth in the S&P 500, implying a combination of organic growth and/or outperformance relative to an S&P 500 benchmark. As shown on the following slide, these changes in fundamentals are not evenly distributed among group constituents.




